SITUATION ON THE FINANCIAL MARKETS as seen by our CIO, Jean-Bernard Georges

After much tension following the bank failures in the United States, as well as the takeover of Credit Suisse by UBS, stock markets recovered a certain calm and are again able to focus on the fundamentals relating to inflation and interest rates.

The US job market remained very resilient in the first quarter, probably excessively so for the taste of the FED. On the other hand, inflation was down significantly at the end of March, 5% at an annual rate as against 6% at the end of February.

Long-term interest rates declined globally in March, and this trend continues into April, leading to gains being made on bond investments.

In this somewhat calmer context, share markets also produced positive performances over the last few weeks.



The situation on the Swiss and international real estate markets remains worrying due to the significant hike in mortgage rates. The volume of transactions is very low, and prices are starting to fall on certain markets.

Prudent deployment of our liquidities continues in successive stages.



PERFORMANCE

The indicative performance of the Foundation's assets was +2.32% as at 31.03.2023, in line with the Credit Suisse index of pension funds at +2.47%, as well as with the UBS index of pension funds of over 1 billion at +2.3%



ASSEMBLY OF DELEGATES

As announced in January, the Assembly of Delegates planned for Thursday 1 June 2023, will be held, as last year, by videoconference but also in person at the Olympic Museum in Lausanne. Voting will again be organised by electronic means. On 24 April 2023 we will send to delegates by post the invitation to the Assembly of Delegates together with the agenda and the CVs of the candidates for reelection to the Board of Trustees.
