SITUATION ON THE FINANCIAL MARKETS as seen by our CIO, Jean-Bernard Georges

Far from the exceptionally warm climate recorded in September, the atmosphere was morose on the financial markets last month. This was mainly due to the marked progression of American 10-year rates. These reached a peak at 4.88% - a level not seen since 2007 – before dropping back somewhat.

With the continued cuts in production by the OPEP countries, oil prices also continued to rise. The combination of these elements led to a sharp decline on the major share and bond markets.

To make matters worse, the USA entered a phase of increased political instability. While a last-minute agreement was negotiated to avoid a government shutdown, this brought about the ouster of the Republican Speaker of the House of Representatives, Kevin McCarthy, accused of treason by a fringe group of the Grand Old Party. Furthermore, the agreement did not make it possible to resolve all the differences, but simply to extend the time limit by 45 days.

The markets have recovered somewhat since the beginning of October, and this despite the tragic events that occurred in Israel, to the stupefaction of the entire world. Even though the oil price



reacted with an increase in the short term, the impact on the financial markets remains very limited for the time being. Any extension of the conflict, which might involve Iran in particular, would lead to far more serious consequences. However, this possibility appears to be rather unlikely at the moment.



PERFORMANCE

The indicative performance of our Foundation's assets is therefore down, posting +1.52% as at 30 September. The same applies to the Credit Suisse and UBS pension fund indexes, with results of 2.77% and 2.6% respectively.



OUR FOUNDATION IS PURSUING ITS DIGITALISATION

From the beginning of the 4th quarter 2023, the balance of your employer contribution reserves account (RCE) will be available on the web portal for business. This will be included in the same document as the evolution of your current account, and will also be mentioned on your invoices.

Our Foundation has established a system allowing you to independently perform calculations and make payments for buybacks through your insured web portal.

If you have made a withdrawal for home ownership encouragement (EPL) or have a deficit due to a divorce payment, our tool will automatically prompt you to repay the EPL withdrawal and/or the divorce reimbursements first.

We strongly urge our insured persons to take advantage of our web portal dedicated to them and easily accessible via our official website www.copre.ch.
